

- · Associate Professor of Social Work
- She was the regional lead for the PROSOWO project (project to professionalise social work in Africa) and serves as copilot in the RESILIENT project (project aimed at strengthening research and capacity building in social work)
- Secretary of the International Association of Schools of Social Work. She served as the vice president of the Association of Schools of Social Work in Africa and is a member of the Capacity Building Committee
- Key research areas: development of professional social work, post-colonial social work in Africa, International Social Work, Social Work Education, child protection, and developmental social work.

### Prof. Dr. Ngozi Chukwu (University of Nigeria Nsukka, Nigeria)

- Associate Professor of Social Work
- Priority areas: Medical Social Work, Family Social Work, Developmental Disabilities, Migration
- Member of many national and international professional bodies regarding social work, bioethics and health research ethics
